Minutes of the 1989 Business Meeting

The Business Meeting was called to order at 8:45 pm, October 13, 1989 by Charles Scott. He offered the Society's thanks to our host, Duquesne University, and to local organizers Wilhelm Wurzer and Tom Rockmore. There were about 400 participants present at this meeting.

1. The minutes of the 1988 Business Meeting were read and APPROVED without correction.

2. Charles Scott announced that David Crownfield would serve as Parliamentarian for this meeting.

3. John Sallis and Lester Embree delivered eulogies in remembrance of Edward Ballard.

4. Program, Membership and Finances

Arleen Dallery presented the statistics for this year's program. There were 143 participants on this year's program. Of these 35 (26%) were women. There were a total of 83 papers submitted for blind review, 52 (62%) of those were accepted. Of the papers submitted for blind review, 18 (21%) were from women and of those 11 (61%) were accepted.

There are approximately 1500 members of the Society (19% - 287 - are women.)

Charles Scott announced that the current balance in the Society's account is approximately \$13,000. He further indicated that the growth in the Society's account will increase the availability of funds to supplement the cost of meetings at schools unable to supply major subventions.

5. Elections

Two Co-Directors were nominated by the Executive Committee: Stephen Watson was nominated for a three-year term as Co-Director and Arleen Dallery was re-nominated for a one-year term as Co-Director.

No further nominations for Co-Director were made from the floor.

The membership ELECTED Stephen Watson to a three-year term as Co-Director and RE-ELECTED Arleen Dallery to a one-year term as Co-Director.
