Accommodations

THE HOLIDAY INN CROWNE PLAZA will provide accommodations for the conference attendees. The hotel is located at 1113 6th Avenue at Seneca Street in the heart of Seattle's downtown business, financial, and entertainment districts. It is two blocks from the Washington State Convention and Trade Center, the site of the SPEP meetings, and within walking distance to many of the city's major attractions. The conference rate will be \$109 plus tax for singles, doubles and twins, and \$114 for triples and quads. Concierge and junior suites are available for \$135, and large suites for \$285 per night. Reservations can be made directly by calling 206/464-1980 or 1-800/521-2762 and should be made by September 9, 1994. Mention that you are attending the SPEP Conference. Rooms are also available for graduate students at the YMCA (206/382-5000) and the YWCA (206/461-4888), which is next door to the hotel, for approximately \$35 for a single. The YWCA accommodates women only and requires a one month advance notice.

Travel Directions to the Conference

The Holiday Inn Crowne Plaza is located off I-5, approximately 20 minutes north of Seattle Tac International Airport. Gray Line of Seattle provides shuttle service between the airport and downtown hotels. Coaches leave the airport every thirty minutes, seven days a week, between 6:00 am and 11:00 pm. Adult fare is \$12 round-trip and \$7 one-way; child fare is \$9 round trip and \$5.50 one-way. Taxi service is available for approximately \$25 one-way. By car, drive north from the airport on I-5 and exit at Seneca Street, one-way traveling west. The hotel is located on Seneca Street between Fifth and Sixth Avenues.

The Convention Center can be reached through the Union Square Plaza; the Plaza is one block North on Sixth Avenue. A walking map will be available at the Holiday Inn.

Minutes of the 1993 Business Meeting

The Business Meeting was called to order at 5:55 pm, October 22, 1993 by John Caputo.

1. The minutes of the 1992 meeting at Boston were submitted for approval. Lester Embree stated that item 9 ought to be revised to show that the Executive Committee agreed to investigate the possibility of making the cost of the SPEP volumes part of the membership dues. The minutes were then approved as amended.

2. David Crownfield was appointed parliamentarian

3. The Society expressed its gratitude to Patrick Bourgeois of Loyola University of New Orleans for his work on local arrangements and to Loyola University for its financial support of this meeting.

4. Linda Alcott, on behalf of the Committee on the Status of Women, expressed her pleasure with the open forum on sexual harassment and suggested that SPEP attempt to initiate an ongoing discussion, beginning with a panel that would allow members of SPEP to begin to conceptualize and handle this problem.

She announced that E. Kuykendall was rotating off the committee. Lenore Langsdorf (Southern Illinois University at Carbondale) was nominated by the Committee and elected by the members present to fill that position.

5. Lenore Langsdorf presented the following statistical information: The Executive Committee received 234 papers for consideration. Of those, 145 were single paper submissions. The Committee accepted a total of 100 papers (from both the single papers and panel submissions). This represents a 43% acceptance rate.

6. Lenore Langsdorf reported a balance in the treasury of approximately \$11,700.

7. John Caputo invited John Sallis to speak in memory of Reiner Schürmann.

8. Future Meetings. The 1994 meeting in Seattle will be held earlier than usual. DePaul University has invited SPEP for 1995. No other invitations were made and DePaul's invitation was accepted. No invitations have yet been made for 1996, and it was suggested that the site be a university in the East.

Jim Risser answered questions about the 1994 meeting in Seattle.

Lester Embree suggested that the Seattle meeting would be a good opportunity to invite scholars from Japan to participate in SPEP.

9. The Executive Committee and the members present thanked Southern Illinois University for its help and support. Thanks were given to Lenore Langsdorf for her dedication, energy, and generosity after seven years on the Executive Committee,

including three as Co-Director. Mariangela Maguire and Karen Smith were thanked for their help and efficiency. Drucilla Cornell was thanked for her services to the Executive Committee.

10. Merold Westphal was invited to conduct elections. Debra Bergoffen was nominated by the Executive Committee to succeed Lenore Langsdorf as Co-Director. No nominations were offered from the floor, and she was elected by acclamation. The Executive Committee presented its nomination of Dorothea Olkowski for the at-large position. It was explained that although the Committee is required to nominate two people to the position, only one candidate could be found. David Crownfield stated that a motion was needed to suspend rules. The motion was moved and accepted. There were no nominations from the floor and Dorothea Olkowski was elected to the at-large position by acclamation.

11. A constitutional amendment to the constitution was proposed to add a permanent secretary/treasurer position to the Executive Committee; the secretary/treasurer would serve a three year term. It was established that the person who would occupy this position would be responsible for organizing the blind review process and would therefore not participate in refereeing papers. S/he would participate in all other Executive Committee matters. The motion carried. The Executive Committee nominated E. Marya Bower to this position. No nominations were offered from the floor, and she was elected by acclamation.

12. John Caputo announced that all correspondence should be sent to him at Villanova University.

13. The floor was opened to new business and announcements.
