GENERAL INFORMATION FOR GUESTS

LODGING

A block of rooms has been reserved for guests at two hotels in West Lafayette: The Purdue Memorial Union and the West Lafayette Hilton Inn. The daily rate at the Purdue Memorial Union is \$18.50 single or \$23.00 twin. The daily rate at the Hilton Inn is \$26.00 for one person or \$36.00 for two persons for a courtyard room; and \$23.00 for one person and \$33.00 for two persons for a noncourtyard room. For preferential consideration and confirmed reservations requests to the Purdue Memorial Union (West Lafayette, Indiana 47907) should be received by October 19th. To be eligible for the above special rate at the Hilton Inn, reservations must be sent directly to the West Lafayette Hilton Inn, P.O. Box 2318, U.S. 52 at Cumberland, West Lafayette, Indiana 47906, or by telephoning (317) 463-5511. The Hilton Inn is about two miles from campus. There is also a West Lafayette Travelodge, North River Road, about eight blocks from campus. The daily rate for rooms at the Travelodge is \$21-\$25 for a single and \$26-\$41 for double. In all cases indicate that you are attending the SPEP Conference.

TRANSPORTATION

For guests traveling by air, the Purdue Airport is currently served by 9 flights a day from Chicago, 8 from Indianapolis, 3 from Detroit, and 2 from Pittsburgh. From 6:00 a.m. to 6:15 p.m. (except Sundays) the airport is connected with the Purdue campus by buses which run every half hour. There are also Greyhound, Trailways, and (on weekends only) Indiana Motor Coach Bus lines to Lafayette. Lafayette is accessible by I-65 from Chicago and Indianapolis.

PARKING

There is a 627-car (Grant Street) parking garage across the street (east) from the Purdue Memorial Union. There is ample parking at the West Lafayette Hilton Inn.

Nine philosophers have agreed to speak on the question, "What would be a pluralistic association of philosophers?" Their comments will be followed by discussion from the floor. The stated purpose of the Committee for Pluralism is: "To work for an A.P.A. which is more representative of the diversity of philosophical activity in the U.S.; to help the A.P.A. achieve its own stated purpose 'to promote the exchange of ideas among philosophers,' and to assure that its self-description is unqualifiedly true: 'The A.P.A. (is) the only organization of philosophers . . . which does not serve a particular interest . . . '; to encourage members of the A.P.A. to participate fully in its acitivites, e.g., to submit papers for the official program written from many points of view, and to attend the business meetings of the Association."
