Accommodations

The meeting will be held at the Georgetown University Conference Center located on the Georgetown campus in Washington, D.C. The address of the Conference Center is 3800 Reservoir Road, NW. The 136 rooms of the Conference Center's Guest House, run by Marriott and located in the Conference Center on the Georgetown campus, have been reserved for members of SPEP attending the meeting. The conference rate will be \$109 plus tax for singles and doubles. Reservations must be made by **September 9, 1996**, by calling directly to 202/687-3232 or toll free 1-800-228-9290. Please request the group rate for the Society for Phenomenology and Existential Philosophy (SPEP). Parking charges are \$12 per day (please be advised that street parking in the Georgetown area is by permit only except at night and on weekends). A block of rooms has also been reserved at the Holiday Inn Georgetown, at 2101 Wisconsin Avenue, NW, which is within 15-20 minutes walking distance of the Conference Center. The conference rate will be \$105 plus tax for singles and doubles. Some rooms will accommodate three or four guests at the same rate (in double beds or pullout sofas; an extra single bed may be added for \$10). Reservations must be made by September 9, 1996 by calling 202/338-4600; please ask for the group rate for the Society for Phenomenology and Existential Philosophy (SPEP). Parking at the Holiday Inn is \$8.50 per day. Since the weekend of October 11, 1996, will be very busy in Washington, reservations should be made as early as possible.

Graduate students may want to form groups of three or four for one room. The Georgetown Philosophy Department will attempt to put individual graduate students in touch with others to form such groups. Those interested should call 202/687-7487. It may also be possible to accommodate a small number of students in the homes or apartments of Georgetown graduate students. Call 202/687-7487 for information. The Youth Hostel of Washington on 15th Street, NW offers accommodations for \$18 per person. Information about the Hostel can be obtained by calling 202/783-6161. The Hostel is not within walking distance of the Conference Center. Other possibilities for accommodations for graduate students include the Howard Johnson's Hotel at 2601 Virginia Avenue in Washington (\$79 for a double room; call 202/965-2700) and the Iwo Jima Motel at 1501 Arlington Boulevard in Arlington, VA, across the Potomac River from Georgetown (\$73.80 double plus \$7 per additional person; 703/524-5000). Both the Howard Johnson's Hotel and the Iwo Jima Motel are within about a thirty-minute walk of the Georgetown Campus.

Travel Directions to the Conference

Washington is served by three airports. Washington National, Dulles International, and Baltimore-Washington International (BWI). Taxi fare from Washington National to the Georgetown Conference Center at 3800 Reservoir Road, NW is approximately \$12. Taxi fare from Dulles is approximately \$45. The Washington Flyer runs buses from Dulles to the Downtown Terminal at 11517 K Street, NW every 30 minutes until 10:20 p.m. on weekdays (last bus to the airport on weekends is at 9:15 p.m.). The bus fare from Dulles to the Downtown Terminal is \$16 one way and \$26 round trip. Taxi fare from the Downtown Terminal on K Street to the Conference Center is approximately \$6. The BWI Supershuttle leaves from Baltimore-Washington International between baggage claim areas 3 and 4 for various points in Washington. The fare to Georgetown is \$24 (\$5 for each additional passenger in a group traveling to the same destination). All fares to the Holiday Inn Georgetown at 2101 Wisconsin Avenue, NW are approximately the same.

AMTRAK serves Washington's Union Station. Service along the Boston-New York-Philadelphia-Washington corridor is fast and frequent. Taxi fare from Union Station to the Georgetown Conference Center is approximately \$7.

Those traveling to Washington by automobile from the northeast on I-95 should take the I-495 West exit toward Silver Spring. Continue on I-495 toward Virginia and exit at the George Washington Memorial Parkway (exit 14). Continue on Parkway and exit onto ramp to Key Bridge. Take Key Bridge across the Potomac and turn right on M Street. Follow M Street to Wisconsin Avenue. Turn left on Wisconsin. To reach the Georgetown Conference Center, continue on Wisconsin to Reservoir Road, turn left on Reservoir and continue to Entrance 1 of the Georgetown University Health Sciences Center. Turn left and follow signs to Conference Center and Guest House. To reach the Holiday Inn Georgetown continue on Wisconsin Avenue to 2101. The inn will be on the right. Approaching Washington on I-270, exit to I-495 toward Northern Virginia. Exit from I-495 onto George Washington Parkway and follow directions above. Approaching Washington on I-66 from 6:30 a.m. to 9:00 a.m. is restricted to cars with three or more occupants. Approaching Washington from the south on I-95 (which becomes I-395 North after I-495) take I-395 toward Washington. Do NOT exit to I-495/95 North. Take exit toward Memorial Bridge and follow signs to Key Bridge, then follow above directions.

1) **Ladelle McWhorter**, Associate Professor of Philosophy, University of Richmond. Ladelle McWhorter earned her B.A. from Birmingham-Southern College (1982) and her M.A. (1985) and Ph.D. (1986) from Vanderbilt University. She is currently Chair of the Philosophy Department and Associate Professor of Philosophy at the University of Richmond. Her publications include an edited volume, *Heidegger and the Earth: Essays in Environmental Philosophy*, and about twenty articles on Foucault, Bataille, and Irigaray, including five articles in SPEP volumes. A book on Foucault and politics is underway. In October of 1995, she was elected to SPEP's Committee on the Status of Women. In January of 1995, she began serving as Co-chair of the Lesbian and Gay Caucus of the APA. At the Central Division meetings, 1995, she was elected Co-chair of the Society for Lesbian and Gay Philosophers.

2) **Ewa Plonowska Ziarek**, Associate Professor, University of Notre Dame. Ewa Plonowska Ziarek (Ph.D., SUNY at Buffalo) is Associate Professor and Director of Graduate Studies in English at the University of Notre Dame. Her areas of expertise include literary theory and continental philosophy, modernism, and feminist theory. She has written on Melville, Kafka, Joyce, Kristeva, Benjamin, Levinas, Foucault, and Derrida. She is the author of *The Rhetoric of Failure: Deconstruction of Skepticism, Reinvention of Modernism*. Currently, she is editing a collection of essays, *Gombrowicz's Grimaces: Modernity, Gender, Nationalism* and working on her next book project, *Ethical Demands: Feminism and Postmodernism*.

BUSINESS MEETING MINUTES SATURDAY, OCTOBER 14, 1995

The Business Meeting was called to order at 12:08 p.m. on October 14, 1995, by Debra Bergoffen.

1. The minutes of the 1994 meeting at Seattle were submitted and accepted without correction.
2. Stephen David Ross was appointed parliamentarian.
3. Debra Bergoffen expressed the gratitude of the Society to Peg Birmingham, David Pellauer, and Katherine Rudolph of DePaul University for their work on local arrangements and to DePaul University for its financial support of this annual meeting.

4. Old Business

A. John Caputo introduced John Wilcox of Spalding University who spoke in memory of Mary Catharine Baseheart, S.C.N., a long time member of SPEP, who passed away this year. Ed Casey also was introduced and spoke in memory of Michel Dufrenne who recently passed away.

B. Dorothea Olkowski introduced Lenore Langsdorf of the Committee on the Status of Women. Langsdorf noted that since its origin ten years ago much progress has been made in the Society regarding the status and visibility of women. Arleen Dallery proposed that the Committee inquire into the status of women in philosophy departments in academia. Langsdorf said she would refer that request to the CSW.

Langsdorf announced that Peg Simons was completing her term on the Committee this year. Ladelle McWhorter, University of Richmond, was nominated by the CSW and elected by the membership to fill that position.

C. Marya Bower presented the following statistical information: The Executive Committee received 211 papers for consideration; of these, 79 were submitted by women. The Executive Committee accepted a total of 109 papers; of these 45 were submitted by women. There are 211 participants on the program; of these 66 are women.

There are approximately 450 - 500 people attending the meeting.

D. Marya Bower presented the budget and treasury report. The opening balance as of September 1, 1994 was \$7,549.97. We have had income of \$16,785.00, for a total of \$24,334.97. The expenses through

August 31, 1995 have been \$14,081.47. This leaves a balance of \$10,253.50.

E. John Caputo invited John Brough of Georgetown University to give a summary of the arrangements for the 1996 meeting. He also announced that SPEP has received a proposal for the 1997 meeting from the University of Kentucky. Ron Bruzina, speaking on behalf of the University of Kentucky, issued an invitation to SPEP for the 1997 meeting and gave a summary of the arrangements. The invitation from the University of Kentucky was accepted by the membership, with thanks. David Crownfield recommended that the Executive Committee inform potential host institutions at the beginning of negotiations that there is a real need for inexpensive, alternative housing for graduate students at our annual meeting. The Executive Committee took the recommendation under advisement.

F. On behalf of the Executive Committee and the Society, Debra Bergoffen expressed the deep gratitude of the Society to John Caputo who is completing a three-year term as Executive Co-Director. She also expressed the Society's appreciation to Bernard Flynn who is completing a three-year term on the Executive Committee.

G. David Rasmussen conducted the elections for the open positions on the Executive Committee. For the position of Executive Co-Director, the Executive Committee nominated Merold Westphal. No nominations were presented from the floor and Westphal was elected by acclamation. For the position of at-large member of the Executive Committee, the Executive Committee nominated Rudolf A. Makkreel and Thomas Nenon. No nominations were presented from the floor. Thomas Nenon was elected to the position.

5. New Business

A. John Caputo presented a recommendation from the Executive Committee that the publication of selected papers given at the annual meeting, *Selected Studies in Phenomenology and Existential Philosophy*, be continued as an annual supplementary double issue of *Philosophy Today*. The charge for this issue will be \$10.00, which will be met by increasing membership dues, beginning in August 1996, from \$25.00 to \$35.00 for regular members, and from \$5.00 to \$10.00 for student and emeritus members. SPEP members who are also subscribers to *Philosophy Today*, which will also increase its subscription rate by \$10.00 beginning with the 1997 volume, will continue to follow the \$25.00/\$5.00 SPEP dues schedule. The first collection of the SPEP volume will appear in 1996. It will be distributed to all dues paying members without charge, but with a request for a voluntary contribution of \$10.00 to offset the one time subvention of \$2,500.00 that SPEP will make to *Philosophy Today* in order to help meet

the costs of printing and mailing this first collection of essays.

A motion was made and seconded to accept this recommendation. After some discussion a vote was taken and the motion carried.

B. Anna-Teresa Tymieniecka of the World Phenomenology Institute thanked the Society for its help in spreading the word about earlier conferences sponsored by the Institute and invited the membership to participate in a new venture entitled "Philosophy, Phenomenology, and the Science of Life" which will hold its first World Congress on April 18-20, 1996 in Italy.

C. Lester Embree announced that the Edward Ballard Fund had received enough contributions to fund a Ballard Book Prize of \$1000.00 that would be awarded to the authors of exceptional works in phenomenology.

D. Hans Siegfried requested that the Executive Committee consider scheduling the satellite groups, which currently meet prior to the conference on Thursday morning, during the SPEP conference itself. The Executive Committee took the recommendation under advisement.

E. Merold Westphal once again encouraged the members of SPEP to continue to submit papers for presentation at the APA division meetings.
