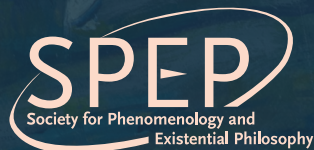

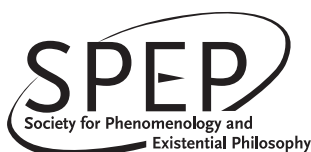

Publication Notice

The SPEP Executive Committee strongly encourages authors to submit papers presented at the annual

meeting for consideration for the *Journal of Speculative Philosophy* SPEP Special Issue edited by the two SPEP Executive Co-Directors each year. To be considered, papers must be uploaded by January 4, 2027 through the JSP online submission system at <http://www.editorialmanager.com/jsp/>. You will need to create an author profile and note the manuscript type as “Special Issue article (SPEP)”; the online system will then guide you through the steps to upload your submission. Submitted papers should be no longer than 4,000 words including notes. Papers should be formatted according to the Chicago Manual of Style and in MS Word format (no PDFs). If the paper is selected for publication, there will be an opportunity for minor revisions. Decisions regarding publication will be communicated by February 8, 2027.

Executive Committee Elections

Dr. Antonio Calcagno will complete his term as Executive Co-Director on the SPEP Executive Committee. An online election will be run through the Philosophy Documentation Center (PDC) for the Executive Co-Director position. The bio of the candidate for this position appears below. All current members of the Society were sent a link to vote. Voting has concluded for this cycle. The results of the election will be announced on the SPEP website as well as at the fall Business Meeting.

The Executive Committee nominates **Christian Lotz** for a three-year-term as Co-Director to replace Antonio Calcagno.

Dr. Christian Lotz is Professor of Philosophy, Associate Chair, and Director of the Graduate Program at Michigan State University. He earned an M.A. in philosophy, sociology, and art history from the University of Bamberg, and a PhD in philosophy from the University of Marburg (Germany), receiving a 2-year fellowship for academic excellence from the Hessian State and a 3-year national fellowship from the German Science Foundation (*Deutsche Forschungsgemeinschaft, DFG*). He spent two years as a graduate research fellow at Emory University in Atlanta. He taught at the University of Marburg, Seattle University, University of Kansas, and the Brandenburg Technical University in Cottbus. His main research area is Post-Kantian European philosophy with foci in phenomenology and critical social philosophy. Monographs: *The Art of Gerhard Richter: Hermeneutics, Images, Meaning* (2015; pbk. 2017); *The Capitalist Schema: Time, Money, and the Culture of Abstraction* (2014; pbk. 2016); *From Affectivity to Subjectivity: Revisiting Edmund Husserl's Phenomenology* (2008); *Vom Leib zum Selbst. Kritische Analysen zu Husserl und Heidegger* (2005). Selected Editions: *Christian Lotz zu Marx, Das Maschinenfragment* (2014), with an extended commentary; *Ding und Verdinglichung. Technik- und Sozialphilosophie nach Heidegger und der kritischen Theorie* (2012, co-ed.). Lotz has published more than 80 papers and 50 reviews in journals and editions on a variety of topics, such as the phenomenology of subjectivity, lived body, memory, affectivity, painting, capital, Marxist method and aesthetics, and social categories, as well as on Continental figures, ranging from Marx and Husserl to Arendt and Foucault. Lotz has served as a member on SPEP's Executive Committee and on the book selection committee.

Dr. Kris Sealey will complete her term as Member-at-Large on the SPEP Executive Committee. **Dr. David Scott** resigned as Member-at-Large. An online election was held through the Philosophy Documentation Center (PDC) for the Member-at-Large positions. The bios of the candidates for these positions appear below. All current members of the Society were sent a link to vote. Voting has concluded for this cycle. The results of the election will be announced on the SPEP website as well as at the fall Business Meeting.

The Executive Committee nominates **Anne O'Byrne** (Stony Brook University) and **Stephanie Rivera Berruz** (Marquette University) for a three-year term as Member-at-Large to replace Kris Sealey.

Dr. Anne O'Byrne, Professor of Philosophy at Stony Brook University, graduated from Vanderbilt University in 1999. She works on radical democracy, feminist political philosophy, race and eugenics, genocide, natality, and theories of anti-imperialism, drawing on an expanding group of 20th century and contemporary European and other thinkers. *Natality and Finitude* (Indiana, 2010) interrogates the existential and political significance of birth in the long wake of Heidegger's thinking. The more recent *The Genocide Paradox: Democracy and Generational Being* (Fordham, 2023) is a study of kinship, taxonomy, and the failure of democracies to resist genocidal violence. She argues against our tendency to treat genocide as an exotic evil; doing so hampers our ability to acknowledge the genocidal violence at the heart of our own democratic states. *Logics of Genocide: Structures of Violence and the Contemporary World* (Routledge, 2020), co-edited with Martin Shuster, takes up the question of atrocious violence and genocide in terms of the institutions and social structures of nationhood, the state, and capitalism. An

earlier volume, *Subjects and Simulations* (Rowman, 2014) co-edited with Hugh Silverman, is a collection of essays on the work of Jean Baudrillard, Jean-Luc Nancy and Philippe Lacoue-Labarthe. Anne is also translator of several works by Jean-Luc Nancy: *Being Singular Plural* (Stanford, 1996), *Corpus II: Writings on Sexuality* (Fordham, 2013), and *Derrida: Supplements* (Fordham, 2023). Her articles and chapters contribute to feminist philosophy—"Heidegger after Brennan" in *Teresa Brennan's Energetics*, "From Care to Solidarity" in *Continental Philosophy Review* and "Communitas and the Problem of Women" in *Angelaki*—as well as to Arendt studies—"The Ugly Psyche: Arendt and the Right to Opacity" in *Research in Phenomenology*, "Améry, Arendt, and the Future of the World" in *Journal of French and Francophone Philosophy*, and "Arendt and Portmann in Search of Meaning" in *Reading Arendt's Denktagebuch*—and to philosophy of embodiment—"Umbilicus: Toward a Hermeneutics of Generational Difference" in *Carnal Hermeneutics*. More recent research concerns a political phenomenology of land and sea, specifically nissological and archipelagic experience from the Caribbean to the fringes of Western Europe. Anne has served as Graduate Director and as Chair of the Philosophy Department at Stony Brook as well as on the executive committee of the Hannah Arendt Circle and the advisory board of SUNY Press. In 2019 she directed the *Collegium Phenomenologicum* on Critical Phenomenology. She would regard it as an honor to serve on the SPEP executive committee.

Dr. Stephanie Rivera Berruz is an Associate Professor at Marquette University (Milwaukee, WI) and a Regional Faculty Associate of the University of Wisconsin-Milwaukee Center for Latin American and Caribbean Studies (CLACS) She is the recipient of the American Philosophical Society Franklin Research Grant (2024-2025), The Way Klinger Young Scholar Award (2021), and the Woodrow Wilson Career Enhancement Fellowship (2017-18) for work on Latinx feminisms, Caribbean, and Latin American philosophy. Additionally, she holds a board member position for Latino Arts, a non-profit organization in Milwaukee, WI, a nonprofit organization dedicated to providing Hispanic cultural arts programming. Rivera Berruz's research is interdisciplinary and explores historiography, social identity, and current political issues that link power, history, and the environment. Notably, her essays, "Latin American Feminisms" (2018); "Latin American and Latinx Feminisms" (2019); and "Feminisms of the Spanish Speaking Caribbean" (2021) charted new historiographical philosophical terrain by creating a genealogy of Latin American and Latinx feminist voices for English speaking audiences. The research therein set the stage for her upcoming manuscript *On the Border of Belonging: Luisa Capetillo, Ofelia Rodríguez Acosta, and Evangelina Rodríguez Perozo* (Rutgers University Press, in production, expected publication June 2027) which explores the lettered traditions of women from Puerto Rico, Cuba, and the Dominican Republic and their philosophical reflections on the role of women in political life at the turn of the 20th century. Her work traverses English and Spanish language use in both research and practice. She recently started teaching philosophy bilingually (English and Spanish). She has published a co-edited anthology *Comparative Studies in Asian and Latin American Philosophies* (2018), and her work has been featured in numerous journals like *The Stanford Encyclopedia of Philosophy*, *Genealogy*, *Hypatia*, *The Inter-American Journal of Philosophy*, *Philosophy Compass*, and *Essays in Philosophy*. Most recently, she co-guest edited a special issue (December 2025) for *philoSOPHIA: A Journal of Transcontinental Philosophy* titled "Composting Man" which invites readers to consider the decay of empire and the unsettling of Man. As part of this collaboration, she published "*Morir-Vivir Beyond the Human: On Partial Ecological Connections and Puerto Rican Futures*."

The Executive Committee nominates **Don Beith** (University of Maine) and **Michael Eng** (Appalachian State University) for a three-year term as Member-at-Large to replace David Scott.

Dr. Don Beith is Associate Professor of Philosophy at the University of Maine and a Faculty Fellow at its Sustainability Center. He is the current President of the Canadian Society for Continental Philosophy/ Société canadienne de philosophie continentale, as well as a member of SPEP's Book Selection Advisory Committee. He published *The Birth of Sense: Generative Passivity in Merleau-Ponty's Philosophy* with Ohio University Press' Series in Continental Thought in 2018. In it, he develops a concept of generative passivity, the idea that our organic, habitual and social activities take time to creatively develop into sense. His more recent work in environmental justice encompasses essays and presentations on biomimicry, animality and literature, moral value in landscapes, ecological slow violence and regenerative ecologies, including: "Animal Phenomenology: Metonymy and Sardonic Humanism in Kafka and Merleau-Ponty" (2023), "From Biomimicry to Biosophia: Ecologies of Technology in Benyus, Oxman, Fisch and Merleau-Ponty" (2021), "Cultivating Ecological Virtues" (2021), and "The Kingdom of Dead Ends: Kant on the End of Nature and Ethics without a Future" (2018). Other new work includes articles about the ways digital technologies transform freedom into new forms of pseudo-agency, among them: "Cage of Empires:

Video Games, Thin Agency and Digital Enclosure” (2026), “Biomimicry in Digital Embodiment: Toward a Generative Concept of Virtual Bodies” (2026), “Thin Agency and the Meaning of Money” (2024), and “Moving into Being: Merleau-Ponty on the Motor Basis of Balance and Literacy” (2017). He hosted the International Merleau-Ponty Circle (2025), The Maine Seminar for Engaged Philosophy (2021), and meetings of the CSCP throughout Canada. He taught philosophy across Canada before coming to Maine, where he has been involved in high school outreach teaching, in starting the first ecological bike-packing club in the country, and in public philosophy.

Dr. Michael Eng is Associate Professor of Philosophy and affiliated faculty in Gender, Women’s, and Sexuality Studies at Appalachian State University. His research areas include post-Heideggerian aesthetic theory, psychoanalysis, critical race studies, feminist theory, critical disability theory, critical algorithm studies, and institutional critique. His writings attend to these areas’ concerns via the themes of language, mimesis, difference, becoming, subjectivization, and narcissism. His book *The Scene of the Voice: Thinking Language after Affect* (State University of New York Press, 2023) takes up the figure of the voice in Martin Heidegger and the continental thinkers who follow him to argue that the dismissal of language by the affective and aesthetic turns in contemporary theory overlooks the common connection language and affect have to the problem of mimesis, which ultimately results in a failure to encounter the relation to difference affect is said to name. Other writings include “Diversity Work and the Narcissisms of Affective Exits” in *Feminist Formations* (2019), “Lights! Race! Gender! Adrian Piper and the Pseudorationality of Data” in *Feminist Media Histories* (2017), “Institutional Schizophrenia and the Possibility of the Humanities’ ‘Other Scene’: Guattari and the Exigency of Transversality” in *Deleuze Studies* (2012), “Genealogy” in *Rethinking Women’s and Gender Studies—Volume II* (2024), and “Philosophy’s Mother Envy: Theory, Affect, and the Possibility of Deconstructing the Mother Tongue” in *Untying the Mother Tongue* (2023). He is currently at work on two book manuscripts: “On the Digital Prehistories of Race” and “The University in the Time of Ecological Crisis” (with Jason Wirth). He is a Visiting Faculty Member in the Whitney Museum of American Art Independent Studies Program (ISP) and a faculty affiliate with the Center for Information, Technology, and Public Life (CITAP) at UNC Chapel Hill. He has served on the SPEP Book Selection Advisory Committee (2019-22), was previously Associate Professor and Shula Chair of Philosophy at John Carroll University, and was a Visiting Associate Professor in Women’s Studies at Duke University.

The SPEP Advocacy Committees intended to nominate two people for a two-year term as the Advocacy Committees Representative on the SPEP Executive Committee. This is the new Executive Committee position, the proposal for which was approved at the October 2023 business meeting. The Executive Committee was unable to find two candidates to run for this cycle.

Best Submission by a Junior Scholar. To be eligible for the SPEP Junior Scholar Award, you must have earned a PhD in the last five years (no earlier than 2021). You must declare your desire to be considered for this prize on the online cover sheet that accompanies your submission. In addition to the \$500 prize, the winner will be granted a travel and hotel allowance. The runner-up for the award will be featured on the program as the SPEP Junior Scholar Award Honorable Mention.

Best Submission by a Graduate Student. All currently enrolled graduate students are eligible for the SPEP Graduate Student Award. You must declare your desire to be considered for this prize on the online cover sheet that accompanies your submission. In addition to the \$500 prize, the winner will be granted a travel and hotel allowance. The runner-up for the award will be featured on the program as the SPEP Graduate Student Award Honorable Mention.

The Iris Marion Young Prize for the best paper in feminist philosophy, awarded by the Committee on the Status of Women. You must declare your desire to be considered for this prize on the online cover sheet that accompanies your submission. The winner will be chosen by the CSW through

anonymous review and will be notified by June 15, 2027.

The Sylvia Wynter Prize for the best paper considering anti-blackness, Africana and Indigenous diasporas, colonialism, post-colonialism, settler-colonialism by a Black, Indigenous, and/or person of color junior scholar (that is, a pre-tenure scholar or graduate student) awarded by the Committee on Racial and Ethnic Diversity. You must declare your desire to be considered for this prize on the online cover sheet that accompanies your submission. The winner will be chosen by the REDC through anonymous review and will be notified by June 15, 2027.

The S. Kay Toombs Prize for the best paper addressing disability, ableism, research in philosophy of disability, and/or research in critical disability studies by a junior scholar (that is, a scholar who has earned a PhD in the five years prior to the submission date) or graduate student awarded by the Committee on Accessibility, Disability, and Inclusion. You must declare your desire to be considered for this prize on the online cover sheet that accompanies your submission. The winner will be chosen by the CADI through anonymous review and will be notified by June 15, 2027. The prize-winning paper will also be invited for submission to the *Journal of Philosophy of Disability*.

The Kyoo “Q” Lee Prize for best paper on LGBTQ Issues in Philosophy by a junior scholar, graduate student, or independent scholar/researcher that 1) engages LGBTQ philosophy, addressing issues of gender, sexuality, queer theory, and/or trans philosophy (especially papers engaging LGBTQ issues in conversation with questions of race, ethnicity, indigeneity, disability, culture, class, migration, religion, and/or age) and/or 2) is submitted by a self-identified LGBTQ author. Priority will be given to scholars who work across genres (broadly construed) in innovative ways. You must declare your desire to be considered for this prize on the online cover sheet that accompanies your submission. The winner will be chosen by the LGBTQ Advocacy Committee through anonymous review and will be notified by June 15, 2027. Awardees will be invited to be formally recognized at the annual LGBTQ Advocacy Committee Session on the main SPEP program.

Minutes of the 2025 SPEP Business Meeting

Shannon Mussett called the meeting to order at 5:20 pm on Saturday, October 18, 2025.

1. Shannon Mussett introduced Antonio Calcagno, Executive Co-Director, Adriel Trott, Member-at-Large, David Morris, Member-at-Large, Kris Sealey, Member-at-Large, and Bryan Lueck, Secretary-Treasurer.

2. Ammon Allred was appointed parliamentarian and timekeeper.

3. The minutes from the 2024 business meeting were submitted and approved without correction.

4. Antonio Calcagno read an expression of gratitude:

The Executive Committee would like to thank Zack Schwartz, Kartik Papaiya, and Adil Hashim from Openwater, and our tech support volunteers for all the work they have done to make this virtual conference possible. The Executive Committee would also like to thank Rawb Leon-Carlyle for serving as SPEP Web Administrator and Shawn Huberdeau for serving as our Public Outreach Graduate Assistant. We would further like to thank the Department of Philosophy at The Pennsylvania State University for providing the funding for graduate student assistant Jules Wong. We would also like to express our gratitude to Western University for providing the funding for graduate student assistant Avery Dawson. And we would like to thank Pam Swope from the Philosophy Documentation Center for ensuring that we are always in possession of up-to-the-minute registration lists.

5. Bryan Lueck presented the following statistical information for the 2025 meeting:

The Executive Committee considered 187 papers. Of the 187 papers submitted, 118 were accepted, resulting in an overall acceptance rate of 63.1%. There are 437 active members. The number needed to reach a quorum at the business meeting is 44. The quorum is met.

6. Bryan Lueck submitted the Budget and Treasury report.

For the fiscal year running from October 1 to October 1, SPEP's total income was \$80,946, and its total expenses were \$100,130, for a net income of \$19,184. It should be noted, though, that the total income does not include registration and membership dues from the third quarter, as we have not yet received that disbursement from the Philosophy Documentation Center. This is always the largest quarterly disbursement. Moreover, because we are meeting online this year, we will not have the large hotel and travel expenses that we typically pay in the weeks following the conference.

As of this meeting, SPEP has \$93,200 in reserve. After we receive the third quarter payment, we are confident that we will have at least \$100,000. This is very healthy compared to previous years. As a point of comparison, our reserves prior to 2020 tended to be between \$25,000 and \$75,000.

7. Dermot Moran delivered comments in memory of Thomas Nenon.

8. The term of Adriel Trott concluded with the meeting. Shannon Mussett expressed the Executive Committee's gratitude to Adriel for her many contributions to SPEP as Member-at-Large.

9. The term of David Morris concluded with the meeting. Antonio Calcagno expressed the Executive Committee's gratitude to David for his many contributions to SPEP as Member-at-Large.

10. The term of Jules Wong as Graduate Assistant concluded with the meeting. Shannon Mussett expressed the Executive Committee's gratitude to Jules for their many contributions to SPEP as Graduate Assistant.

11. The term of Avery Dawson as Graduate Assistant concluded with the meeting. Antonio Calcagno expressed the Executive Committee's gratitude to Avery for his many contributions to SPEP as Graduate Assistant.

12. The SPEP Executive Committee was pleased to announce the results of this year's online elections. John E. Drabinski was elected to a three-year position as Member-at-Large on the Executive Committee. John replaced outgoing Member-at-Large David Morris at the conclusion of the Business Meeting. The Executive Committee thanked Scott Marratto for his willingness to stand for election. Gayle Salamon was elected to a three-year position as Member-At-Large on the Executive Committee. Gayle replaced outgoing Member-At-Large Adriel Trott at the conclusion of the Business Meeting. The Executive Committee thanked Jill Stauffer for her willingness to stand for election. The Executive Committee reminded the membership to submit nominations on the SPEP website for individuals to serve on the Executive Committee.

13. Andrew Cutrofello gave a brief report about hosting SPEP at Loyola University Chicago in 2026. Shannon Mussett invited members to host or co-host an annual SPEP meeting. Those interested in hosting a meeting may contact any member of the Executive Committee.

14. Summer Renault-Steele presented the report for the Committee on the Status of Women. The winner of the Iris Marion Young Prize is Cressida Heyes. The term of Summer Renault-Steele concluded with this meeting. The Committee on the Status of Women nominated Rachel Silverbloom for the vacant position. Rachel Silverbloom was elected by acclamation.

15. Ellie Anderson presented the report of the Public Outreach Committee. Ellie Anderson's term concluded with this meeting. The Public Outreach Committee nominated Gil Morejón for the vacant position. Gil Morejón was elected by acclamation.

The 2026 SPEP panel is titled "Philosophy in an Age of Authoritarianism." It will feature talks by Linda Martin Alcoff (Hunter College, CUNY), Janine Jones (UNC Greensboro), and Shannon Sullivan (UNC Charlotte). David Scott (Coppin State University) will moderate. The 2026 SPEP session at the Eastern APA meeting will take place on Friday January 9, 2026, from 7-10 pm. All SPEP members and friends of continental philosophy are invited to attend.

21. David Morris informed the membership that collection of demographic data would be suspended until further notice.

22. Shannon Mussett opened the floor for discussion of how to foster space to do work around diversity, justice, and inclusion without putting our members at risk. The following issues were raised:

- Difficulty for people who travel to conferences in the United States because immigration officials look at the titles of papers.
- Suggestion that content could be made accessible only to members with passwords.
- Advocacy for A/V cost negotiations for international participants who cannot attend in person.

23. New Business:

Kristi Sweet informed the membership of a job opening at Texas A&M.

24. Antonio Calcagno adjourned the meeting at 6:40 pm.
